Sonae – SGPS, SA, hereby gives you notice, according and for the purpose of the set forth in article 1, paragraph c), and of article 2, paragraphs 2 and 3, of the Portuguese Securities Commission (CMVM) Regulation nr. 5/2008, by reference to the notice sent to your Company on 15 February 2013, of the alteration to the voting rights attribution title of a qualified shareholding above 66% (sixty-six percent) in your Company's share capital, as result of the acquisition, over-the-counter, on the present date, of 73,249,374 (seventy-three million, two hundred and forty-nine thousand, three hundred and seventy-four) shares, representing 20% (twenty per cent) of your Company's share capital.
