Proposal number 2

Under the legal and statutory terms, the Board of Directors proposes to allocate the net income of Sonaecom Individual accounts, in the amount of 42.774.663,52 euros as follows:

- i) 2.138.733,18 euros to legal reserves;
- ii) 25.841.223,07 euros is paid to shareholders;
- iii) 14.794.707,27 euros to "Other Reserves"

Considering that it will not be possible to determine the precise number of own shares that will be held by the company on the date of the abovementioned payment, without limiting the company's capacity to act, we highlight the following:

- i) To each issued share it will correspond the gross amount of 0,083 euros;
- ii) The amount corresponding to the shares that belong to the Company on the payment day of the abovementioned amount (calculated on said unit gross amount of 0,083 euros per issued share) will not be paid to shareholders, but will instead be maintained in "Other Reserves".
